Professional Installation Warranty

For MASTERGRAIN Manufactured Fiberglass Entry Door Systems

MASTERGRAIN is committed to delivering superior performance and long-term peace of mind. That commitment includes not only exceptional products but also the assurance of professional installation. When a MASTERGRAIN fiberglass entry door system is purchased directly from MASTERGRAIN and is installed by an authorized MASTERGRAIN installer, it is backed by the following installation warranty.

Coverage

MASTERGRAIN warrants that the installation of your fiberglass entry door system will be free from defects in workmanship that materially affect the performance, fit, and structural integrity of the door system for a period of two (2) years from the original date of installation. The warranty period begins on the date of the installation of the product, provided that full payment for the product has been made.

This installation warranty applies only to door systems:

- Installed by MASTERGRAIN, and
- Installed in owner-occupied, single-family residential homes within Ontario, Canada.

During the warranty period, MASTERGRAIN will correct any installation-related issue that affect the operation or proper weather-sealing of the door at no cost to the homeowner, including adjustments, realignments, and resealing-provided the issue is not due to misuse or structural settlement.

Limitations

This Installation Warranty does not cover:

- Installations performed by non-authorized or third-party contractors
- Issues arising from settling, shifting, or structural movement of the building
- Installation of storm doors or aftermarket components
- Damage caused by improper use, abuse, or lack of maintenance
- Caulking and weatherstripping after the first year (these are considered homeowner maintenance items)
- Water infiltration or performance issues due to inadequate overhangs or exposure to

extreme elements

• Any removal and reinstallation costs for alarm systems, moldings, flooring, or other surrounding finishes

If the product is removed, reinstalled, or altered by anyone other than MASTERGRAIN or its authorized agents, this Installation warranty is void.

Hardware-Specific Clause

This warranty covers adjustments or service only on hardware that is supplied and installed by MASTERGRAIN. For hardware supplied but not installed by MASTERGRAIN, service may still be available; however, additional charges will apply.

Transferability

This Installation Warranty is non-transferable and applies only to the original purchaser and installation address. Any transfer of ownership or relocation of the door system will void this installation warranty.
